## FINANCIAL REPORT

Profit /Loss – Gerry Schmit

- 1. Gerry reviewed a graph created to review historical expenditures which indicates that we are on track with past spending trends.
- 2. Our expenses are higher than expected, but much is due to "pass through" of expenses that related to corresponding income like grants. We did have some unexpected expenses like the last payment on the Engine, however we also had unexpected income from the conflagration.
- 3. We have exceeded our income this fiscal year. Income low for February, but our property taxes for March were bigger and not reflected on our books yet.
- 4. Property Taxes are variable, and we are looking at historical data to reflect more accurately in the next fiscal year budget.
- 5. For the upcoming budget, we will be cleaning up the chart of accounts and matching up to the LB forms.
- 6. Change in dates for the budget meeting process. Initial meeting will be on May 14<sup>th</sup> at 7pm and the follow up meeting (if needed) will be May 20<sup>th</sup>.
- 7. LGIP accounts are exceeding interest expectations.

- Volunteer Association Report:
  - O Volunteer Association did not meet in March..
- Emergency Preparedness:
  - o Upcoming dates: Firewise Open House 4/27/2024 from 11am-3pm Fire District Open House 6/8/2024 from 11am-3pm
  - O Logsden Community Center generator is there and people are being trained to operate it. Potentially need a bigger propane tank.
- Evacuation Planning with a couple of different committees working on different scenarios and Chief has been attending these meetings. There will be an upcoming tsunami evacuation and overnight test scenario at the Newport Airport and the Scappoose Fire Chief who has drone experience will also be there. Future meetings include "Island" mapping for the geographical islands or isolation areas that could happen in an event like a tsunami or earthquake.

- Reviewed the 911 Systems increase in fees for the next fiscal year.

- The McKenzie Scott foundation is looking for grand recipients and a letter in inquiry was sent.
