- Emergency Preparedness: Discussion focused on our recent situation with the ice storm and multiple day loss of power:
  - Reviewing current generator and what is being powered at the station and what could be added.
  - o Gas station not functioning, need gasoline storage.
  - o Overall, City of Siletz and Tribe had challenges due to the length of the power outage.
  - o The community had a great need for oxygen and oxygen generators.
  - o Ongoing communications issue in Logsden discussed deploying two-way radios.
  - o Food security discussed with need to have food available for all in the community.
- Received National Firewise USA Program Certification.

### **CHIEF REPORT**

- Motorhome Fire out in Moonshine.
- Daniel is doing the upgrade and creating his office, should be up and running in a few weeks.
- Rubber mats for engine to sit on would be helpful.
