CHIEF REPORT

NEW BUSINESS

SVFD Board of Directors Regular Meeting December 21, 2021

There are companies that handle all the paperwork and process that many Oregon fire agencies use. That agreement might come before the board at a later date.

We'll need to establish a policy on how and when these charges get implemented but this is the first step in the process.

Moved by Patti and 2nd by Gerry to approve Resolution 2022-1 for final adoption in January.

Trailer -There is a trailer parked by the Conex box behind the station. The history was explained that it was on a FP&S grant that the chief wrote back in 2012. Its unclear what we will do with it.

Surplus Equipment- Resolution -The chief presented a list of items he would like to surplus as we don't seem to have a need. He has presented this to the Officers who seemed in agreement. Director Olson commented he would like to have the chief double check and see if there was either some sentimental or other reason folks didn't want to get rid of any of these items. This was based on some previous history. The chief assured him he would check with everyone again.. there was no hurry on this.

With no further questions or comments This was moved by Dixie and 2nd by Reggie to approve Resolution 2021-06 by title.

SDAO -the chief did a number of the surveys online. He encouraged the board to do these as the come up as it gives us a discount on our insurance.
